ALANA KING SAYS

I hope Warne is looking down and feel pretty proud

MANCHESTER: Australia leg-spinner Alana King paid a fantastic tribute to the legendary Shane Warne in epic style, claiming the first-ever hat-trick in women's edition of The Hundred, propelling her team Trent Rockets to defeat Manchester Originals by 43 runs. Co-incidentally, Alana took her hat-trick in The Hundred on the very same ground where Warne bowled the ball of the century and bamboozled England's Mike Gatting in the 1993 Ashes series. "The hat-trick is pretty special. I hope (Shane Warne) is looking down and is pretty proud I spun it a bit. That's my first hat-trick. Not even in juniors did I take one. My first hat-trick at Old Trafford, I couldn't have written it. Will I get my name up here at Old Trafford? That would be brilliant. Hopefully right next to Warnie. He took poles for fun here," said Alana.

AGAINST ENGLAND DUE TO HIP FLEXOR INJURY

Duanne Olivier ruled out of South Africa's Test series

LONDON: South Africa's right-arm fast bowler Duanne Olivier on Sunday was ruled out of the upcoming three-match Test series against England due to a grade two right hip flexor muscle tear. Olivier sustained the injury during South Africa's four-day tour match against England Lions at The Spitfire Ground St Lawrence in Canterbury, where he picked 2/59 in the first innings. "Duanne presented with significant discomfort involving his right hip flexor muscle at the close of play on day three of the four-day tour match. After clinical assessment, he was referred for an MRI scan which revealed a grade 2 tear involving the right pectineus muscle."

DAYS AFTER ELGAR'S 'EGG ON THEIR FACES' REMARK

Billings warns South Africa Test skipper

LONDON: Days after South Africa skipper Dean Elgar said he is not impressed with England's new aggressive and brave style of cricket -- also called 'Bazball' after their new Test coach Brendon 'Baz' McCullum -- England cricketer Sam Billings has warned that it would be "pretty stupid" on the part of the touring side captain to disregard the approach, which has earned the hosts four back-to-back victories in Tests. Elgar, who is touring England for a three-Test series beginning August 17 at Lord's had recently said, "There was often parity between England and New Zealand (during the Test series) and had New Zealand taken their opportunities, and their catches, then things could have been very different. England would have come away with egg on their faces."

SANJEEV RAJPUT SAYS

In 2012, I kept waiting forever for approvals



NEW DELHI: Indian rifle shooter Sanjeev Rajput sure has left his contemporaries way behind! While the likes of Abhinav Bindra, Gagan Narang and Samaresh Jung, after achieving great success in the sport, have moved on, Rajput, 41, continues to aim for Olympic glory, knowing well that he still has a few more years of competitive spirit left in him to achieve his dream.

The disappointment in 2020 Tokyo has spurred him to aim for success in 2024 Paris and Rajput is hoping lady luck will shine on him two years from now, what with the shooter hailing from Yamuna Nagar, Haryana recently getting married and finding the motivation to "go for it" one more time with a brand new Walther rifle. The 2018 Gold Coast Commonwealth Games gold medalist believes the government's Target Olympic Podium Scheme (TOPS) has made life easy for sportspersons and cut those endless waits, which left athletes frustrated.

EXCERPTS:

Q: Has the government's Target Olympic Podium Scheme made life easy for athletes like you?

A: It certainly has made the life of athletes easy. Really easy. I would say. An athlete now has to forget about everything and just concentrate on preparation and competition. I remember before the 2012 London Olympics I had made a plan to train abroad for three months and sought NSDF (National Sports Development Fund). But I kept waiting for 60 days for approval. With only 30 days left, I made a decision that I could not train in the hot and humid conditions of Delhi. I spent from my pocket to go abroad and train for the remaining 30 days. I could only train for 24-25 days, while the original plan was for 90 days.

To bring home medals from Paris

Indian boxers need to punch above their weight

NEW DELHI



Indian boxers had a fine campaign at the CWG 2022 as they finished second in the boxing medal tally with three gold, one silver and three bronze. However, if one compares it with the 2018 Gold Coast show (then nine medals), the pugilist slipped a bit this time!

The good news is that some young talents managed to impress and could be good future prospects. And bad news is some big names failed, making the Boxing Federation of India a little worried. And why not? Because the federation (BFI) under Ajay Singh has been working really hard on its boxers with providing all the expositers they need.

Speaking, a boxing coach on condition of anonymity said that the boxers will have to work really hard if they want to achieve a medal in the Paris Olympics.

"The draw at CWG was comparatively easy. But then also most of our promising boxers failed to have podium finishes. I am not saying that a boxer didn't work hard but CWG gold is something which gives you confidence that you can do better in Asiad and then Olympics," the coach said. "In 2018, our six boxers reached the finals out of a 12-member team. But only four this time. So, we need to work really very very hard," he added.

Boxing is certainly one of India's best sports which have brought in multiple Olympic medals. Apart from shooting, wrestling and hockey, boxing has proved to be one of India's most productive medal-winning sports. Even during last year's Tokyo Olympics, Assam's Lovlina Borgohain won a bronze medal for the nation.

Tymal Mills to miss remainder of The Hundred due to toe injury

LONDON

England left-arm pacer Tymal Mills is set to miss the remainder of The Hundred men's competition due to toe injury. Mills had taken the field for his side Southern Brave during The Hundred 2022 on Wednesday night after giving himself time to heal from toe injury.

But a report in ESPNcricinfo says that his toe flared up yet again after Wednesday's match and he didn't play in Southern Brave's next match. "He had surgery on Friday morning, which will be followed by another procedure on Wednesday, ruling him out of the rest of the tournament," said the report. The report further said that Mills is aiming to be fit in time to tour Pakistan in September, where England play seven T20I matches before flying to Australia for three T20Is and subsequently, the Men's T20 World Cup to be held from October 16 to November 13.
